Paid Time Off (PTO).

After the first year of employment, in January, the employee will automatically receive forty (40) hours PTO if hired by June 30th, (These hours will be prorated if the employee is hired on or after July 1st.)

Employee will also accrue hours per payroll; Accrued is based on the years of consecutive full-time service (40hpw), 4.63, 6.16 or 7.70 hours.
